**Chapter 238.20.C.1** Allowing occupancy of a residential rental unit without a valid residential rental license, (including but not limited to relinquishment of license due to a failure to apply, a failure to pay the rental license fee, or following the revocation of a license), will be subject to a fine of \$500 per residential rental unit for each month the violation exists, a term of imprisonment not exceeding 90 days, or both. Each month the violation exists constitutes a separate violation. Notwithstanding the foregoing, no fines shall be imposed for any period during which the residential rental unit is vacant and the owner or property manager, is taking action to correct the violations.

**Chapter 238.20.C.2** Whoever violates any other provisions of this article shall be subject to a fine of not more than \$1,000 or a term of imprisonment not exceeding 90 days, or both. Each month that a violation exists constitutes a separate violation.

I acknowledge, and understand, that failure to comply with the requirements of **Chapter 238.7** may result in a citation of up to \$500.00 every month the violation exists and/or 90 days in jail and/or license revocation or a citation of up to \$1000.00 every month the violation exists and/or 90 days in jail and/or license revocation (Chapter 238.20 C.1).
