

# CALL FOR ARTISTS: ILLUSTRATORS AND GRAPHIC DESIGNERS

Request for Qualifications (RFQ) River Connections - Rosie the Fish

Budget: \$3,000

### **Project Description**

The City of Lancaster is seeking a qualified artist to develop a cartoon character for web and print and to illustrate coloring sheets for web and print.

The character, named Rosie the Fish, is an animated ambassador to educate the public, specifically school-aged residents, about the river and the work done through the River Connections project.

## **About River Connections**

In 2022, the City of Lancaster launched River Connections with the goal of elevating the stories of Black and Brown people's connection to the Conestoga River. By storytelling through various mediums, the River Connections team cultivated a greater sense of stewardship and community around the river. Local artists created and performed works that represent their connection to the river to a broader audience. Through spoken word, visual art, film and music, the need for care and repair of the Conestoga River is spreading throughout Lancaster's neighborhoods. ### <u>Artwork Specifications and Project Deliverables</u>

Rosie the Fish should be designed to be both a static graphic and a collection of simple animated GIFs. The GIF should be animated in 4 different actions. Actions may include waving, pointing, diving, etc. The GIFs will be shared on the program's website, social media platforms, and other digital promotional material. In addition to creating the character of Rosie, the artist will illustrate a 4-page coloring sheet collection featuring Rosie the Fish and her mother Mary the Fish.

Coloring sheet content may be as follows:

- 1. Rosie meeting a bear near a river
- 2. Rosie meeting 3 ducks at a pond
- 3. Rosie looking at a people fishing on the shoreline with a water treatment plant in the background
- 4. Rosie meeting an owl at the Conewango Dam
- 5. Rosie meeting a crab at the Chesapeake Bay

## **Eligibility**

This commission is open to all professional artists, or a team thereof. Applicants must be 18 years or older. Applicants must be able to pass the following clearances:

- Criminal Background Clearance (Act 34)
- FBI Federal Criminal History Fingerprinting (Act 114)
- Child Abuse History Clearance (Act 151)

The selection committee will select artists without regard to race, color, religious creed, ability, ancestry, national origin, age, sexual orientation, or gender identity.

- A statement of interest
- Resume
- Portfolio that includes 5-10 images of previous artwork relevant to project scope

## **Selection Process**

Prospective candidates are invited to submit applications on or before Monday, June 24, 2024. A selection committee will review applications and select up to three (3) finalists by Friday, June 28, 2024. Finalists will be notified and scheduled for an interview with the selection committee. The artist to receive the commission will be announced on Friday, July 19 2024. The following week, the selected artist will meet with the project manager to develop a work plan.
